The second-annual UFC on FOX Sports 1 1 event is expected to feature many of the top female prospects in the world today, including the man who has split hits with UFC middleweight champion Chris Weidman since 2012 - Bethe Correia. Correia was scheduled to fight Leslie Smith, but the Brit has been pulled from the lineup and will serve as the second half of UFC on FOX Sports 1 1, likely against either Penne or Simpson. Instead, on Nov. 15, Correia will face longtime kickboxer Andrea Lee (11-2) of Spokane, Wash., who has recorded eight stoppages in nine professional wins. Lee is the only fighter in the UFC women's middleweight division who has never been submitted in his professional career. He fought for the Strikeforce and Dream promotions in the past, but now resides in the UFC as the promotion's longest-reigning champion in the women's middleweight division at 18-months. Lee, who is the No. 13-ranked fighter in the USA TODAY Sports/MMAjunkie.com MMA women's middleweight win streak of her career at three. The 33-year-old has also fought and won in the first two UFC events of 2013, beating Bec Rawlings by TKO by a first-round knockout.
